## Notes

Faculty status (full or part-time) is primarily based on the employee's class (class code beginning with 'F'). Only tenured or tenure tack faculty are classified as full-time faculty in the FON report. Retired faculty (i.e., budget code beginning with 'R') are classified as part-time faculty, independently of class or group code.

De Anza Child Development Center teachers (class code 'F3') are reported as classified employees (i.e., not included in the FON calculation).

Only data for credit courses are included in FTO calculations.
