Proposed District Planning Model

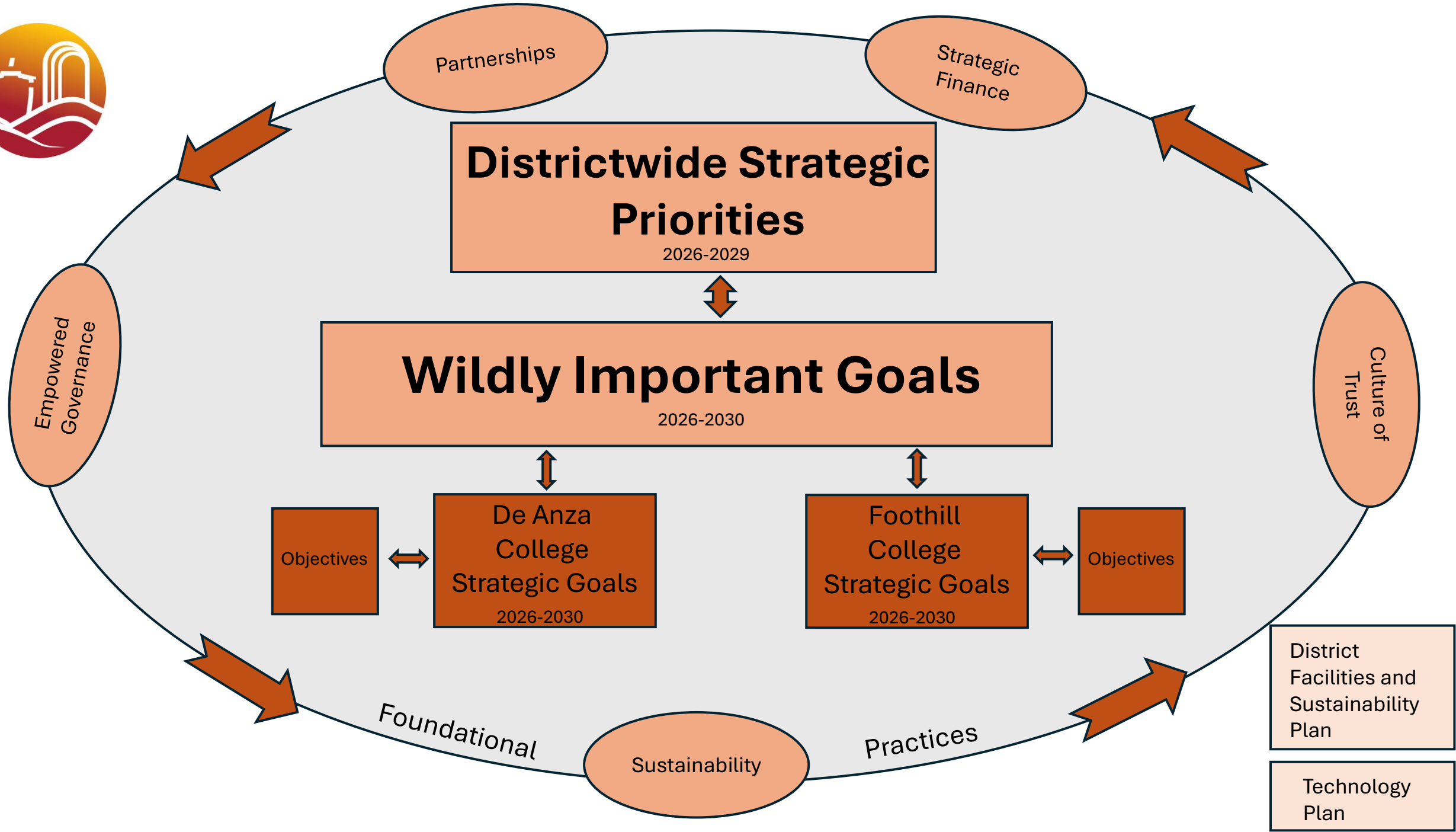
- **Simplify the cycles**
 - **Three-year cycle for the district plan**
 - District plans will inform college plans
 - **Five-year cycle for college plans**
- **Simplify the plans**
 - **Focus planning efforts in one Strategic Plan at each college and the district**
 - The colleges will be guided by their own strategic plan with overarching guidance from the district strategic plan to focus on execution
- **Align Plans**
 - **Supporting District Plans align with district timeline**
 - District Facilities and Sustainability Plan will align with the district Strategic Plan and inform college Strategic Plans
 - District will lead the development of supporting plans with consultation from the colleges
- **Align with Accreditation Cycle**
 - **Institutional Self-Evaluation Report (ISER) will be based on existing Strategic Plans**
 - **Evaluation of the ISER will align with future Strategic Plans**
 - Midterm report – Fall 2028
 - ISER writing – 2029-2030 (District provides Standards III and IV)
 - ISER due – Fall 30
 - Site visit – Fall 2031

- **District Foundational Practices**
 - The five practices enable goal accomplishment
- **Districtwide Priorities**
 - The five priorities inform the Wildly Important Goals
- **Wildly Important Goals**
 - Breakthrough strategies that impact student success and achievement informed by the districtwide priorities
- **College Strategic Plans**
 - Foundational practices and districtwide priorities inform college plans
 - Colleges establish goals and objectives to meet their mission and help the district achieve its priorities
- **Supporting Plans**
 - Inform the district and college strategic plans
