Introduction

This document provides summary statistics for the MIS Assessment (MIS SA)¹ report for the 2015-16 year (July 1 of 2015 to June 30 of 2016), which was submitted on March 2017 by the Foothill-De Anza Community College District (FHDA) to the California Community College Chancellor's Office (CCCCO). In contrast to the MIS Data Mart,² the figures shown here are for student headcount (non-duplicated student count)—not for the number of tests, as shown in the data mart. In this document, data are disaggregated by college, MIS assessment, and local test descriptor (as shown in SOATEST, Banner). With the purpose of facilitating the review of the data to detect any problem that may have impacted the accuracy of the report, the document also provides (a) headcount figures for the current and prior

submission years and (b) a crosswalk between codes in the local information system (Banner) and the MIS Assessment Inventory.³

Results

Excluding the English as a Second Language (ESL) writing sample, data in Table 1 show a decline between 2014-15 and 2015-16 for the number of students who took at least one course placements test at De Anza College; 9% decline for total headcount. In Table 3, data disaggregated by subject area show a decline of 11% for English and Math, and an increase of 2% for ESL. Data in Table 3 also show that close to 80% of all students who took at least one placement test at De Anza College during this period, took at least one for Math course placement; this compares to about 70% for English and about 20% for ESL. Table 4 shows a crosswalk between SOATEST and MIS assessment codes for De Anza College used by the program that produces the MIS SA report.

Data for Foothill College in Table 2 show a different trend, when compared to data for De Anza College. Student headcount figures for ESL assessments show a decline of about 2% between 2014-15 and 2015-16, while the English and Math assessment show increases that range from 5% (reading comprehension) to 18% (elementary algebra). However, data disaggregated by subject area in Table 3 show a slight decline (1%) between these two years for the total number of students who took at least one assessment for Math course placement at Foothill College. The difference between observed trends in Table 2 (individual tests) and Table 3 (all tests combined) for the Math area is caused by a significant increase in the number of students who took more than one placement test (testing at different levels) for this area in 2015-16 at this college, when compared to the number for the previous year.

For English, the percentage in Table 3 was similar to that in Table 2—about 5%. Data in Table 3 also show significant differences between the two colleges for the English subject area. During the last two years, Foothill College students were less likely to take English placement tests (about 56%), when compared to students at De Anza College (about 68%). Table 5 shows a crosswalk between SOATEST and MIS assessment codes for Foothill College used by the program that produces the MIS SA report.
