- Re: Validation of SARS data for the MIS Student Success report, fall 2015

Introduction

With the purpose of validating the procedures used to extract and report data from the SARS¹ system at De Anza College for the MIS Student Success (SS) report, ² student headcount figures are provided in this document and segregated by location,³ reason for the appointment or meeting, and student demographics so that all relevant parties at the College can review these and report any unexpected findings. Detailed headcount figures for each SARS location segregated by reason and SSSP⁴ service are also provided in Appendix A to facilitate data review by SARS users at the College, including how these services are reported in the MIS SS report.

The figures presented here are based on SARS data for meetings that occurred between September 1 and December 31 of 2015 (fall 2015), with emphasis on appointments or meetings for which at least one of the reasons was to provide SSSP services. A crosswalk or lookup table between SARS meeting reason codes and the data fields in the MIS SS report was used to identify SSSP core services provided at each of the SARS locations. Demographic (i.e., gender, age, race/ethnicity, and residency) and education level related statistics (i.e., exempt status, first term at the college) for students who received

SSSP services at SARS locations are shown and compared to related figures for the College student population in fall 2015⁵ to identify and address any problem with the data or reporting procedures.

Results/Discussion

- There were 19 SARS locations at De Anza College with data for meetings scheduled in fall 2015 (see Table 1). Data in Table 2 show the 11 SARS locations where SSSP services were provided during this term. Table 3 shows 8 SARS locations where, based on SARS meeting reason codes, SSSP services were offered; however, no data for actual meetings were found for fall 2015. Some of these locations with missing data seem to be a duplicate of another location (i.e., *Counseling Division*, ID 40; *EOPS Center*, ID 2) or locations that became active in the winter 2016 term (i.e., *Biological Health Environment Sciences* and *Asian American Pacific Islanders*).
- SARS locations or areas that did not offered SSSP services in fall 2015 included the *Biology* Lab, Health Services, SSC WRC Tutoring, SSC Learning & Speaking Center, General Subjects Tutoring, Academic Skills Center, SSC Writing & Reading Center, SSC General Subjects Tutoring Center. These are primarily places where health and tutoring services, which are not classified as SSSP services, are provided.
- Data in Table 1 show *Counseling and Advising* with the largest headcount and percentage of students served and services provided (student headcount, 52%; services, 59%), including services not related to SSSP. Specific to SSSP or Student Success (SS) services, Table 2 shows *Counseling and Advising* with 68% of the student headcount and 54% for the number of services provided. On the other hand, the data also show that at least 32% of the students in SARS who received SSSP services, received these outside of *Counseling and Advising*. Other SARS locations with a significant number of students who received SSSP services in fall 2015 include the *International Student Office*⁶, the *Transfer Center*, and the *EOPS Center* with 15%, 13%, and 10% of the student headcount, respectively.
- Figures in Table 4 are meant to compare the workload for these services across different SARS locations to take into account the student population served at the place (i.e., to explore the extent to which students who received services in some of these locations may require more services than students served at other locations). Services for student ratios in Table 4 were

used as a measure of workload per student. Data in this table show larger ratios for the *Psychological Services*, *EOPS Center*, and *Athletics AA* locations where, on average, students attended more than two meetings to receive SSSP services or received more than two type of services at each meeting during fall 2015.

- Figures in Table 5 to Table 12 compare demographics for students who received SSSP services at SARS locations in fall 2015 with related figures for the College student population for this term.⁷ The purpose is to identify significant differences in percentage figures that may signal issues with the data. If differences in student groups (i.e., students segregated by demographics) regarding SSSP services are found, then address whether these differences are expected (e.g., nonexempt⁸ students are expected to receive more SSSP services than exempted students).
- Related to Gender, Table 5 showed that females were, to a small degree, more likely to receive SSSP services than males at these SARS locations. The 2 percentage point difference may be a statistical artifact⁹ or a sign of actual differences between gender groups.
- Regarding age, figures in Table 6 show that younger students are more likely to receive SSSP services at these locations than older students; same results for nonexempt students when compared to exempt students in Table 7. SARS data is expected to show higher student headcounts and percentages when compared to related data for the College student population for many SSSP services such as orientation, assessment, and education plan development are mainly intended for applicants or first-time nonexempt students.
- No significant differences for first academic year at De Anza College in Table 8 were found between percentage figures for students receiving SSSP services in SARS locations and the College student population. The slightly higher percentages for students beginning attendance in recent academic years are likely related to students' age and exempt status.
- Figures for California residency status, one of the criteria used for SSSP allocations,¹⁰ in Table 9 indicate that foreign or international students were more likely to receive SSSP services at these locations, especially when compared to in-state students. Also, the number of foreign or international students who received SSSP services at these SARS locations was about half the

number for the College, while for California residents the number of students who received SSSP services at these locations was about a quarter of the related number for the College. These significant differences are expected if one takes into account that federal regulations require close monitoring of the academic progress of F-1 visa students enrolled at the College.

Regarding race or ethnicity, Table 10 shows that Asians were more likely to receive SSSP services at these SARS locations than students from other races or ethnic groups, while Whites or Caucasians were less likely. However, these race or ethnic differences were found to be better explained by student residency status and age. When taking into account residency status, figures in Table 11 show that Asian California residents were significantly less likely to have received SSSP services at these locations than any of the other groups. When taking into account age, figures for students younger than 25 in Table 12 show that Asians and Whites or Caucasians were about 5 percentage points less likely to have received SSSP services at these locations than students from other ethnic groups, when compared to related figures for the College student population. An issue to further explore is the extent to which receiving SSSP services is related to academic performance, which has been shown to be related to race/ethnic group classification.
