Re: Student headcount by SSSP service, first-time enrollment, basic skills, and declared education goal status; De Anza College, 2015-16

Overview

The following document provides headcount figures by SSSP (Student Success & Support Program) service based on data submitted in the MIS¹ SS (Student Success) report for De Anza College, 2015-16 academic year. Data for preenrollment services (orientation, assessment/placement, and education plan development) are disaggregated by student first-time enrollment status ("First-Time" or "Other"). First-time students are those who enrolled at De Anza College for the first time in any term of the 2015-16 academic year or during the summer or fall of 2016-17 (incoming first-timers), not including enrollment as special admit, and who did not have prior higher education experience when they first enrolled at the College.² Headcounts for pre-enrollment services only include students who received the service at De Anza College for the first time (initial service) between July 1, 2015 and June 30, 2016.

Related to counseling, probation, and follow-up services, headcount figures are disaggregated by student basic skills and declared education goal status. Basic skills students are those who enrolled for the first time in at least one basic skills course at De Anza College between the academic years of 2014-15 and 2016-17 (prior, current, or follow-up academic year). Declared education goal status is based

on whether the student had identified an education goal by the end of the academic year, 2015-16. Headcounts for counseling, probation, and follow-up services include students who received the service at De Anza College any time between July 1, 2015 and June 30, 2016.

Results




Figure 1. First-Time Student Headcount by 3SP Initial Service, De Anza College, 2015-16

Data in Table 1 and Figure 1 show headcount figures for orientation, placement, and education planning initial services disaggregated by student first-time status. Percentage figures in this table indicate that, as expected, these services are mainly provided to first-time students. Results also show that assessment/placement is the service most used by students, especially first-time students (78%). These figures do not include students served during a prior academic year; in particular, students who participated in outreach activities for high schools in the area during the spring quarter for 2014-15.




Figure 3. Basic Skills Student Headcount by 3SP Service, De Anza College, 2015-16

Data in Table 2 show student headcount figures for counseling, academic probation, and follow-up services provided at De Anza College between July 1, 2015 and June 30, 2016 disaggregated by student basic skills and declared education goal status. Figure 2 and Figure 3 show headcount figures for students who enrolled in at least one basic skills course and who declared "undecided" as their education goal, respectively. Percentage figures in Table 2 indicate that basic skills students tend to receive these services to a greater degree than the general student population.³ Data in this table show no significant differences in percentages for headcount figures between students who have not declared their education goal and the general student population.

Other: Student who had previously enrolled at De Anza, with prior higher education experience, only enrolled as special admit, or applicant (did not enroll in either 2015-16 or 2016-2017).


